

DOMESTIC LIST

The Domestic list is a sanction list of terrorists and terrorist financiers prepared and approved by the National Counter Terrorism Committee in accordance with its powers and responsibilities provided for by the Prime Minister's Order n° 001/03 of 22/01/2025 governing the National Counter-Terrorism Committee. The list includes 25 individuals who have been involved in Terrorism or Terrorist Financing activities.

Information about appeal or de-listing may be found in the Prime Minister's Order n° 001/03 of 22/01/2025 governing the National Counter-Terrorism Committee, published in the Official Gazette n° Special ter of 22/01/2025. Information about sanctions applied to those designated individuals is in the Regulations n° 001/FIC/2025 of 15/01/2025 relating to targeted financial sanctions.
